Annual Report 2019
Minister's Report January 26, 2020

You only need to take a quick walk down the south side of Wooster St. from Main St. to Basin St. and turn your head to the left in order to see some of what's been accomplished around here as of late. The exterior of the Church has been repaired and repainted, the parking lot has been resealed and relined, the front stairs of the Parish Hall have been restored, and two large trees in the backyard have been removed. Other projects that may be slightly less obvious to the naked eye but that are equally important include the broken water main for the Church that has been replaced, the door buzzer system on the Church and the security system on the Parish Hall that were installed, the plumbing that was fixed in both buildings, and the electrical issue in the Parish Hall that was resolved. 2019 was a really busy year at St. Paul United Church of Christ, to say the least. We are truly thankful to our Church Council and to all the volunteers who came together — contributing their time, talent and treasure — to make all of this happen.

And yet, as we all know full-well, the work of being a church is never truly finished; there will always be more for us to do. As the stewards of an older set of structures that take up the better part of a block in the village, we should not be surprised that our church's physical presence will continue to consume a significant share of our resources for the foreseeable future. But maintenance of buildings and grounds is definitely not all that church-work entails.

There are, for example, the Soup & Salad and Garage Sale lunches — with the virtual army it takes to make them happen year after year; there are the hours and hours of rehearsal time put in by our choir and bell choir every September to June; there are the confirmands and mentors who study on their own and meet with me once a month to reflect upon faith formation; there are the funeral meals that are so lovingly prepared and served by members of our community whenever they are needed; there are the teachers and volunteers who work to offer Sunday School for both children and adults; there are all of the members who pledge their time and effort to serve on Church Council and other committees.

The life of our church, of course, extends well beyond the time we spend together on Sunday mornings. And what we do here relies not only upon the efforts of our church staff, but also — and perhaps even more so — upon all of you. But we also need to recognize that the life of the church must also extend well beyond us.

With so many of our significant and urgent property maintenance needs now in the rearview mirror, I am hopeful that in the coming year we can increasingly turn our attention outward to our community and to our world.

After much effort over the past year, our Church Council and its sub-committees of Trustees, Elders and Deacons are now positioned to deal with both day-to-day and longer-term logistical issues more autonomously and efficiently. During 2020, we will take this work to the next level as we contemplate and consider — with assistance from our Association — whether the governance structure that is delineated in our current by-laws is actually the best one for us going forward. The ultimate objective of these organizational initiatives is to allow us to think more proactively and strategically in the years to come about how we can engage with the issues that demand our attention and the people who need our help, about how we can love our neighbor as we love ourselves, just like Jesus calls us to do.

To that end, at our last meeting I challenged each of the members of the incoming Church Council both to identify a need they see in our community *and* to propose a way in which we, as a church, might work to meet that need. I look forward to hearing their responses at our next gathering in February. In the meantime, though, I'd also like to extend that challenge to all of you by asking you this: What is important to you? What is important to our community? And how can we work together for the benefit of all God's people?

We must, of course, be realistic because we will not be able to do everything. But we should dare to think and dream big because we can definitely do some things. And the things we do might even help to change the world.

Congregational Meeting
December 8, 2019

President Jim Savage called the meeting to order. Ed Whitmore stated that there was a quorum.

President Savage thanked the congregation and stated that the meeting's dual purposes were to approve the budget and ask for approval of council and committee members. Usher passed out the budget and ballots. There was a round of applause for the deacons committee and treasurer Matthew Feucht.

President Savage detailed the various categories in the budget and whether there was an increase or decrease. For example, the pastor search is over, so there were no search expenses. There's also a decrease in the amount allotted to property maintenance. Increases are for salaries and real estate taxes. Lynne Indorf asked about the pianist salary.

Bob Benson made a motion to approve the budget, and Tim Alter seconded. The motion carried. Members of the congregation voted on the budget, which was approved unanimously (57-0).

There will be a capital improvement campaign going into next year. Trees around the parsonage may be removed.

Council and committee members are approved so that they can be ready to take their positions at the start of the new year. Outgoing council members are President Jim Savage, Ed Whitmore, and Esther Berlyoung, and new council members are Susan Whitmore, Evelyn Jones, and Barb Specht.

There will be Christmas Eve services at 7:00 and 11:00, with Communion being served at the 11:00 service. The Congregational meeting will be January 26.

President Savage thanked the nominating committee, and there was a round of applause. Jim Gaal is starting his second term on the council, and Sarah Whitmore and Sara Amato are starting their second term on the Board of Christian Education. Since Susan Whitmore and Barb Specht are leaving the Pastor-Parish Relations committee to join Council, Rose Whitmore and Kathy Eichelberger are filling the vacant positions. Lori Salopek and Margaret Weber are starting their second terms on the Music Committee.

Charlie Snyder made a motion to close nominations, Randy Yoder seconded. The motion carried via a hand vote.

There was a motion by Bob Benson to approve the nominations. Flo Hoover seconded. The motion carried by hand vote.

Charlie Snyder thanked outgoing President Jim Savage for his service. Jim thanked the congregation for involvement in decision-making and its patience. He thanked Reverend Brent Gundlah, council members past and present, and God for guidance.

Bill Bair made a motion to adjourn, and Mike Kuhn seconded. The motion carried.

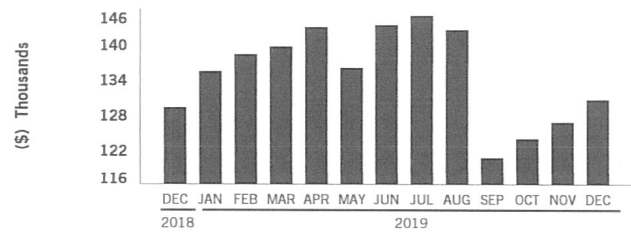

The below chart displays the most recent thirteen months of Market Value.

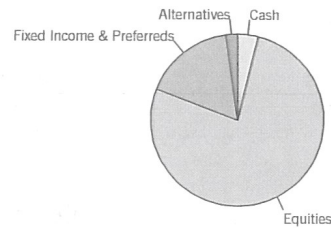
